The Peer Assistance Monitoring Program at the Foundation of the Pennsylvania Medical Society has experienced remarkable growth. With the inclusion of licensed pharmacists and nursing professionals, our staff has doubled,

and the number of participants served annually has nearly tripled. This exponential growth reminds us that the journey to recovery is deeply personal. It is critical to acknowledge the nuances of the various licensees and state boards we support.

In response to feedback from key stakeholders, including the Pennsylvania Pharmacists
Association, the Pennsylvania Society of Health-System Pharmacists, and members of our PHP Advisory Committee representing pharmacy, the Foundation has implemented microbranding tailored to specific licensees. This initiative aims to create a strong and distinctive identity that resonates with the pharmacists we serve.

At a recent Board of Pharmacy meeting and during the annual Pharmacists Association meeting, the Foundation proudly unveiled the PharmHP logo. In addition to the logo, customized marketing materials are being developed, and a dedicated PharmHP website is currently in progress. Through these efforts, we aim to foster unique, personalized connections and meaningful engagement with our participants and stakeholders representing pharmacy.

As the Peer Assistance Monitoring Program continues to evolve, additional microbrands

will emerge, including the Dentists' Health Program (DHP) and the Nurses' Health Program (NHP). These microbrands will serve to further strengthen the sense of identity and belonging among the licensees we support.
